

# Terms of Use — Information Systems

## 1. Scope

---

These Terms of Use ("Terms") apply to all users who access information systems, applications, networks, devices, and digital resources owned or managed by PX Center Group ("PX Center"), including contractors, interns, and third-party service providers with granted access.

## 2. Acknowledgment

---

By clicking "Accept," you confirm that you have read, understood, and agree to comply with these Terms and all referenced policies listed in Section 5. Acceptance is recorded and retained for audit purposes in accordance with applicable data protection regulations.

## 3. Acceptable Use

---

You are authorized to use PX Center systems solely for legitimate business purposes. The following activities are strictly prohibited:

- Accessing, copying, or disclosing confidential information without authorization.
- Installing unauthorized software or circumventing security controls.
- Using systems for personal commercial activity, illegal content, or harassment.
- Sharing credentials, tokens, or access keys with other individuals.

- Connecting personal or unmanaged devices to internal systems without prior IT approval.

#### **4. Monitoring and Privacy**

PX Center may monitor system activity, network traffic, and device usage to the extent permitted by applicable law. Monitoring is conducted for security, compliance, and operational purposes. Any personal data collected through monitoring is handled in accordance with PX Center's Privacy and Data Protection Policy (POL-SEG-029) and applicable data protection laws, including LGPD and GDPR where applicable.
